he last decade is the one that has seen the most rapid reforms and developments in terms of regulatory and procedural compliance, transparency and digitalisation, both in Cyprus and globally," Andrea Antoniou (33) says excitedly. "The work of lawyers and service providers has changed significantly, requiring a great extent of care and diligence. I believe that I belong to the generation of lawyers that contributed to revolutionising the market and assisting traditional law firms to reinvent themselves in order to survive. What emerged from this challenging decade was how to turn challenges into opportunities and accept that uncertainty is part of the game." As technology extended rapidly into virtually every industry and profession, Cyprus' dated legal system came perilously close to being left behind but - better late than never - the politicians and lawmakers finally responded with reforms. "The 7th and 14th of July 2022 are arguably the most important dates for the legal system and the legal community of Cyprus, as the House of Representatives reached agreement on amending the Constitution," Antoniou says, and confirms her own belief

"Cyprus' legal system has been strengthened with mechanisms that will modernise the judicial body and improve the efficiency and quality of judicial proceedings and court decisions," she explains. "Most importantly, there will be specialisation amongst the judges while the separation of the Supreme and Appellate courts will also be based on specialty, a development that guarantees the system's efficiency, the quality of rulings and fasttrack procedures. The legal community of Cyprus, the Cyprus Bar Association, the Ministry of Justice and the Justice Committee of the Parliament have worked closely for several years and cooperated on well-drafted legislation and on convincing the key stakeholders and the political parties of the imperative need to move forward with this historic development."

Andrea Antoniou's professional persona has been shaped by her belief in the power of determination, optimism, integrity – both individual and collective – and in doing your best, always striving to surpass yourself.
